This notice is an abbreviated notice of a long form notice. In case of any discrepancies between the abbreviated notice and the long form notice, the provisions of the long form notice prevail. A new notice may be published upon final judgment of this class action.

TAKE NOTICE that a judgment authorizing a class action was rendered on April 1, 2020 by the Superior Court of Québec in file 500-06-000937-181 against the Réseau de transport métropolitain (exo) (hereinafter « EXO”) and the Autorité régionale de transport métropolitain (ARTM) (the “**Class Action**”).

This Class Action aims at obtaining a judgment ordering the payment of compensatory damages, as well as punitive damages by EXO, to the users who allegedly suffered damages as a result of the alleged faults against EXO and the ARTM that would have resulted in commuter train delays and cancellations on the Deux-Montagnes or Mascouche train lines between November 1, 2017 and February 28, 2018.

This Class Action is to proceed in the judicial district of Montreal.

**Who is a Class Member?**

“Class member” is defined as the following: “All persons who paid for a transport ticket issued by EXO to travel on train line Deux-Montagnes or train line Mascouche, on any date in

between November 1<sup>st</sup>, 2017 and February 28<sup>th</sup>, 2018.”

2. The expression “transport ticket” comprises all forms of paid transport tickets and/or passes as issued by EXO.

A class member who does not discontinue an originating application having the same subject matter as the Class Action before the time for opting out has expired is deemed to have opted out.

If a member is not a class representative or intervenor, there are no fees to pay in relation to the present Class Action.

**You may opt out of the Class Action** if you do not wish to be involved in the Class Action against EXO or the ARTM. However, in case of a settlement or judgment providing for compensation to the class members, you will not be authorized to make a claim.

**How to opt out?** To opt out, you must notify the Clerk of the Superior Court of Quebec in writing by providing the following information:

- Your name, address and telephone number;
- Your declaration: *I am a class member and I want to opt out of the class action;*
- Your signature.
